- NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Chandragupta Maurya College of Education, Plot no -319/320, Street no - Bihta, Vill- Kala Bhagwanpur, Po - Sarasat, Tehsil/Taluka - Patna, Town/City -Patna, Dist - Patna, Bihar - 801109 for conducting D.El.Ed. programme of two years duration with an intake of 100 (two basic units) from the academic session 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
